
4 Rules of Firearm Safety

FROM THE PRESIDENT'S DESK

March is a busy month at NTS, especially the first weekend. On March 2 we'll hold our annual game dinner from 2 until 6. This year we were sold out in under a week! As always we'll have the 50/50, sportsman's item raffle and a raffle for a \$100 Field and Stream gift card. We're not asking for donations this year but if some show up we'll be sure to get them to the VMC.

The following day, March 3 we'll hold our annual election of officers and board members. Sarah Cole has signed on as Secretary to replace Eric Einbinder who is stepping down. No officer candidate was opposed so the secretary will cast one vote for each to be elected at the March meeting. There are 3 board seats to vote on this year since we had a resignation a few months ago. This one alleviates some of the paperwork regarding senior members. The second submitted by John Ward increases the dues to \$100 a year for full members and will be voted on at the April meeting.

March 9 will have a Rensselaer county Pre License class at 8:00 a,m, Indoor range certifications at 12:30 for members and Rensselaer Post License Evaluation starting at 1:00 p.m.. The Rensco class/eval cost \$50 for each.

All guns are purchased for the 2019 Gun Raffle as well as the ATV. Guns will be through Smitty's Trapping and Outdoor Supply in Schaghticoke and the ATV again through Edelmann's in Pittstown. Tickets will be available at the May meeting and our thanks to Eric Einbinder for continuing on with this task.

The winter Pistol (AFPL, women's and Thursday) and archery leagues carry on through March and into April.

Proposed Bylaw Change to Article 11 - Submitted by John Ward

Article 11 Existing

- (C) Full Member 21 years of age or older, pays \$80.00 annual dues and initiation fee of \$120 when joining. Full use of club facilities.

Article 11 Proposed

(F) Full Member - 21 years of age or older, pays \$100.00 annual dues and initiation fee of \$100 when joining. Full use of club facilities.

ARTICLE 11

- 1. LEVELS OF MEMBERSHIP (existing)
 - (G) Full Member 21 years of age or older, pays \$80.00 annual dues and initiation fee of \$120 when joining. Full use of club facilities.

Senior Full Member - Any member who is 70 years old or older, that has paid their dues continuously for 20 years without interruption and has been in good standing, shall be entitled to pay one half the annual full member dues and still retain all the privileges of full member. Members must apply three months before the January 1st deadline for their dues every year. The board of directors must approve each member that applies yearly.

(H) PROPOSED

(i) Senior Full Member - Any member who is 70 years old or older, that has paid their dues continuously for 20 years without interruption and has been in good standing for at least the 20 years, shall be entitled to pay one half the annual full member dues and still retain all the privileges of full member. Members must apply by October 1 of the prior year to become a senior member. Once approved by the Board they will be carried forward as "Senior Members" for as long as they remain in good standing with no further action required by the member or the Board.
