18 New Member FACTS – KNOW AND UNDERSTAND!

- 1. Dues must be paid BY JANUARY 1st each year!**
- 2. All Federal and NYS laws/regulations will be observed.**
- 3. You are on probation for a period of 1 year after your initiation.**
- 4. New members are not allowed to bring guests to the club for 1 year after being voted in.**
- 5. New members cannot recommend other persons for membership for 1 year.**
- 6. New members cannot seek office for a year after they are voted in.**
- 7. Observe all range closures, safety rules and painted firing lines on all ranges.**
- 8. Use of alcoholic beverages or illegal drugs is prohibited prior to use of any range. Alcoholic beverages or illegal drugs are prohibited on any range.**
- 9. No shooting on any outdoor range before 9:00 am**
- 10. No shooting after sunset, times are posted. (use your head too – don't make the neighbors mad).**
- 11. You must sign in the range book before you use any range on the club and sign out when finished.**
- 12. You must be certified to use the inside firearms range.**
- 13. No firearms are to be uncased or unboxed in the social (bar area) of the club.**
- 14. No guests are ever permitted on the inside firearms range.**
- 15. Report any broken or misused club property to an officer, board member, or committee chair immediately.**
- 16. You are expected to participate in the semiannual work parties at the club (last Saturday in April, first Saturday in October).**
- 17. Refer to your copy of "Range Rules and Practices" you received for more details or to cover other topics not mentioned here.**
- 18. Ignorance of rules does not excuse you from the rules – ask, and find the answer to questions!**
